MINUTES OF CHAPTER MEETING LAKE NOW SEPTEMBER 17, 2014

Date, Time, Location: September 17, 2014, 7:00 p.m. W.T. Bland Library, Mount Dora, Florida

Count of Members and Guests: 14 members and 5 guests were in attendance, for a total of 19 in all.

Presiding Officer: Sandra Gray Paradise, President. Also in attendance: Carol King, Immediate Past President (arrived late); Vice-President, Lucinda McGinn; Membership Director, Deana Goldstein; Karen Salvat, Treasurer; and Barbara Hill, Secretary.

The meeting was called to order at 7:02 p.m. by President Sandra Gray Paradise. Meet the Candidate:

Linda Bozeman introduced Mike McKenna, who is the winner of the primary for the District 10 U.S. Congressional seat. Mr. McKenna is a Democrat and a member of Lake NOW. He spoke for several minutes with regard to his vision for equality for all and how much respect he has for the NOW's position on this issue.

Program:

Lucinda introduced Ann Jordan who presented a slide show and videos entitled *Women Under Sharia: The Problem Not Permitted a Name*. Ann Jordan is a teacher, blogger, activist, and a member of Sarasota-Manatee NOW. It was a powerful presentation reiterating the treatment of women living under Sharia Law; i.e. thousands are kidnapped, raped, sold into slavery and girls as young as eight are wed to men old enough to be their grandfathers. It is a story of male supremacists treating women solely as housekeepers and breeders. An interesting discussion followed.

After a brief recess, the meeting continued at 8:25.

Officers Reports:

Financial – Karen Salvat:

- Karen reported the Chapter has \$500.11 in the savings account (\$.11 is a dividend), and \$3,034.18 in the checking account.
- T-shirts are available for \$30.00, and name tags are available for \$12.00.
- Raffles for a free membership through the Sisterhood Fund are \$2.00. Because there
 was enough money to draw for a free membership, a number was drawn and Barbara
 Hill was the winner.

- At the Florida conference, the Chapter's vendor table made \$174.00. There are more items to be sold, so these items will be available at the Eustis First Friday on October 3rd.
- Karen reminded us the purple bucket is on the table: "Change for Change."
- Karen also reminded us to register to vote.

Other Events and News:

- Sandee read a thank you note from Judi Phillips Jones for the plant sent to her by members of the Board on behalf of Lake NOW.
- Mary Flanagan and Sandee attended the NOW quarterly council meeting. The council recommends voting in favor of Amendments 1 and 2 on the November Ballot (conservation funding and medical marijuana, respectively), and voting in opposition of Amendment 3 which would grant an outgoing governor an opportunity to appoint judges to the bench as he/she leaves office.
- The bid for the May 2015 Florida NOW conference was awarded to Venice, Florida. No specific date has been selected.
- The National NOW convention will be held June 20 in New Orleans.
- The Lake NOW Chapter will be collecting items for the Lake School Families in Transition Program (FIT). Items to be collected include cereal, peanut butter, shelf milk, sanitary napkins and tampons. Members are requested to bring the items to the next meeting and Sandee will ensure they are delivered to the FIT program.
