- 1. AGENDA TOPICS:
 - a. Approval of previous month's minutes:
 The chapter meeting minutes from February 18, 2015 were approved without change.
 - b. Financial Report:

Lucinda reviewed fund raising and monetary gains made by Lake NOW.

- 1) Seven seats were filled at the Dora Drawdy event. The table was purchased by Lake NOW for \$200.00. At \$25.00 per seat, we were able to reimburse our chapter with \$175.00.
- 2) Lake NOW participated in the "Relay for Life". Deana reported that over \$1200.00 was raised at the event to benefit the American Cancer Society.
- We invested \$25.00 for a table at the state conference in Venice, FL and sold \$146.00 worth of merchandise.
- 4) Six new members have joined Lake NOW.

- c. Review of State conference held in Venice, FL from May 15-17, 2015:
 - 1) Lake NOW members in attendance were Mary, Lucinda, Nancy and Phyllis
 - 2) Mary Flanagan won the election as Membership Director. She led a workshop on ways to promote and build new membership. Later, at the state council meeting, a strategic project was initiated focusing on new and creative ideas to build membership. Mary discussed the structural change process that National is going through and specifically for changes on how monies are transferred from the National level to Chapters in order to help create a balance between active and non-active chapters.
 - 3) Nancy attended three workshops; Court Watch and the Restoration of Voting Rights for Ex-Felons. She also attended and helped facilitate a workshop on Legislative Issues.

2. FACILITATED DISCUSSION/PRESENTATION:

- a. Nancy Hurlbert delivered a thorough overview of the 2015 legislative issues utilizing a comprehensive chart which outlined Democratic legislative priorities. Bills that were supported, opposed and no position were summarized. Nancy stated that although NOW is non-partisan, many of the proposed progressive issues are supported by NOW.
 - 1) Some of the categories reviewed by Nancy were; the Budget, Healthcare Expansion, Criminal Justice, Disability Rights, Education, LGBT Rights, Voter's Rights and Women's Rights.
 - 2) Nancy stated that the budget did not pass and a new session will convene for 20 days this June in order to get the state budget passed.
 - The 5.1 billion dollars for Medicaid expansion was turned down the past two years. Nancy stated that we need to contact our representatives and senators and tell them that we want those monies offered to help with and improve healthcare in our state.
